ABOUT THE FACULTY OF HEALTH SCIENCES

The Faculty of Health Sciences comprises three schools:

- Allied Health
- Behavioural and Health Sciences
- Nursing, Midwifery and Paramedicine

There are currently approximately 14,000 students (EFTSL) and 520 (FTE) staff in the faculty under the disciplines: occupational therapy, speech pathology, social work, exercise science, exercise physiology, nutrition science and dietetics, biomedical science, nursing, midwifery, paramedicine, digital health, physiotherapy, psychology and public health. The Faculty is represented across seven ACU campuses.

The Faculty's research broadly addresses the Future Healthcare Worker, Health across the Lifespan, and Human Performance, with some of our current research focused on Cardiovascular Disease, Metabolism, Health Services Research, Nutrition, Sports Performance and Rehabilitation, Psychology, and Mental Health.

An expanding portfolio of postgraduate courses is also available in coursework and research. ABOUT SPEECH PATHOLOGY

The Bachelor of Speech Pathology Program at ACU is offered on three campuses: Melbourne, North Sydney and Brisbane. The program aims to prepare students to assess and diagnose difficulties with communication and swallowing, and enables them to provide intervention and support that is person-centred, culturally-sensitive and evidence-based. Consistent with the mission of ACU, the program is underpinned by values including a respect for the dignity of the human person, commitment to social justice, equity, advocacy, and a responsibility to the common good. The program comprises speech pathology theoretical units, inter-professional units, and professional practice units. Meritorious students may be eligible to undertake an embedded Honours program in third and fourth year. POSITION PURPOSE

A Lecturer in Speech Pathology (Level B) is expected to contribute to the development and implementation of the Bachelor of Speech Pathology at Australian Catholic University by providing theoretical and clinical teaching and research. The Lecturer in Speech Pathology will consult with the Head of School and Assistant Deputy/Deputy Head of School of Allied Health, National Head of Discipline, Course Coordinators of Speech Pathology and other staff as required, ensuring that the delivery of the Speech Pathology curriculum is comprehensively managed.
