The needs and experiences of children and young people represent a particular focus of our work.

ICPS is committed to engagement and impact. We interact with research end-users to develop projects that support evidence-informed work with and for children and young people. We aim to promote children's rights, needs, interests and views and influence the development of policy and the provision of services to children, young people, and families. ICPS uses findings from our work to build workforce capacity and enhance community awareness, as appropriate.



## **POSITION PURPOSE**

The primary purpose of the Research Fellow/Senior Research Fellow is to produce high-quality applied research to contribute to and strengthen the University's research profile, and more specifically the profile of the Institute. The Research Fellow/Senior Research Fellow will have experience child-focused research initiatives, and the translation of research findings to inform decision-making. The Research Fellow/Senior Research Fellow will augment the current work of ICPS in areas including but not limited to supporting child-safe communities, strengthening child protection service systems, and informing practice, and promoting children and young people's participation in research.

The position holder will work with ICPS staff to identify and secure applied research projects and support the measurement and evaluation of child abuse prevention and other related initiatives to support the safety and wellbeing of children and respond to the needs of those affected by abuse and neglect. As appropriate, the role will also contribute to the engagement and impact initiatives designed to prevent child maltreatment and promote safeguarding strategies in youth-serving organisations. This position is ideal for candidates passionate about applying advanced research skills to deliver on projects that have application to children's safety and wellbeing.
