General Position Statement:

This position supports Council's direction by providing a range of investigation, survey, design, drafting and documentation services associated with municipal infrastructure and other projects undertaken by the Infrastructure Design team.

Specific Responsibilities:

This position has the following responsibilities:

- 1. Application of high level skills and knowledge to investigate, prepare and critically review detailed designs, drawings and cost estimates for moderately complex municipal infrastructure projects.
- 2. Undertake accurate field surveys, prepare feature plots and terrain models and carry out set-out surveys for projects.
- 3. Provide project support and technical advice to other staff in the Infrastructure Design team.
- 4. Provide accurate information and technical advice to the public, other organisations and Departments within Council when required.
- 5. Ensure that Council policies, processes and procedures are followed and that all work meets technical and quality specifications and codes.





- 6. Exercise a significant degree of initiative and judgement where policies, processes and procedures are not clearly defined.
- Act as a role model for Council's Values and Behaviours at all times and display a high level 7. of professional and ethical conduct.
- Refer matters that may impact upon the business, Council and employees to the relevant 8. Supervisor or Manager.
- 9. Undertake other relevant duties as directed, consistent with skills, competence and training.

- 2. The ability to prepare and review detailed Civil Design construction drawings and cost estimates for inclusion in project documentation relevant to Council's Municipal Infrastructure.
- 3. High level knowledge of statutory requirements and design standards relevant to Council municipal infrastructure projects. This may include (but not limited to) CMDG, MRTS, Austroads, QUDM, Australian Standards etc.
- 4. Ability to effectively operate Council's computer and technology systems including:
 - Electronic Record Management Systems
 - Microsoft Office Suite
 - Computer aided drafting software, in particular Civil 3D, however 12D will also be highly regarded
 - Survey equipment, GPS RTK and Total Station.
- 5. Good communication (verbal and written) and interpersonal skills relevant to the position and the ability to work effectively as a member of a Civil Design team.
