1.1 Contribute to the Facilities & Open Spaces Arboriculture Unit by performing arboricultural works and other tree maintenance duties.

3. Key Responsibilities

- 3.1** Apply sound and accepted arboricultural practices in undertaking tree maintenance duties in accordance with agreed standards and timeframes.
- 3.2** Apply arboricultural knowledge in the identification, care and maintenance of trees, including pest and disease identification and control, pruning, planting and fertilising.
- 3.3** Drive and operate elevated work platform, woodchipper and associated arboricultural equipment, including pneumatic saws, chainsaws and climbing equipment in accordance with the manufacturer's specifications.
- 3.4** Perform routine minor repairs including blade replacement of the chipper, daily pre-start checks and operator maintenance in accordance with the manufacturer's specifications, report maintenance and service requirements to team leader.
- 3.5** Work cooperatively with other staff in meeting the work requirements of the team and provide arboricultural support to the organisation as required.
- 3.6** Maintain accurate work records including work diaries, time sheets, plant log sheets, and arboricultural records

4. Core Physical Requirements

- 4.1** Capacity to, on occasion, lift items unspecified in weight within individual limits.
- 4.2** Capacity to work in an outdoor environment for varying periods of time.
- 4.3** Capacity to stand/walk for periods up to 3 hours.
- 4.4** Capacity to sit/drive, operate plant & equipment for periods up to 3hours.
- 4.5** Capacity to walk/ negotiate uneven and sloping ground.
- 4.6** Capacity to drive a motor vehicle.
- 4.7** Capacity to undertake arboriculture works, including frequent tree climbing.

5. Accountability and Extent of Authority

- 5.1** designated work area to ensure that work requirements for the team are met.
- 5.2** Accountable for the application of relevant arboricultural knowledge in the care,

identification and maintenance of trees, including pest and disease identification and control, pruning, planting and fertilising.

5.3 Accountable for fulfilling obligations under the Occupational Health and Safety Act and relevant regulations and Council's OH&S Policy, observe safe work practices, report unsafe conditions or practices to the team leader.

5.4 Accountable for the effective maintenance and operation of plant and equipment.

6. Judgement and Decision Making

6.1 Tasks are undertaken using established procedures, objectives are well defined but the particular method, technology, process or equipment to be used must be selected from a range of available alternatives.

6.2 Problem solving will require some originality in approach with solutions usually attributable to applications of previously encountered procedures and practices. Guidance and advice are always available to make a choice.
