## **3. Key Responsibilities**

### **3.1 Fitness Program Delivery**

- 3.1.1** Design and conduct innovative, safe and effective workout programs both for individuals and for circuit-based gym groups – based on client need.
- 3.1.2** Maintain supervision and support of participants at all times, including correcting dangerous technique when observed.
- 3.1.3** Use a thorough needs analysis and goal-based approach in determining individual clients' needs and coach the individual through their plan.
- 3.1.4** Evaluate and monitor participation in fitness programs.

### **3.2 General**

- 3.1.1** Maintain a safe and pleasant environment for members and guests and other staff.
- 3.1.2** Ensure the health and safety of all patrons using the facilities by ensuring the behaviour of customers is conducive to the provision of a safe leisure environment.
- 3.1.3** Drive the WSAC retention program by providing contact and follow up calls and emails, as prescribed, to non-attending members.
- 3.1.4** Assist the Aquatic & Health Programming Coordinator in the development of new and innovative programming opportunities or operational improvements.
- 3.1.5** Maintain a high standard of personal presentation, openness and be approachable to clients and staff.
- 3.1.6** Manage incident situations including delivering first aid and acting as an area



warden for the gym, and document all follow up reporting requirements as per WSAC policy and procedure.

- 3.1.7** Ensure any issues or problems that arise are dealt with in accordance with WSAC procedure and policy.
- 3.1.8** Immediately report all maintenance, feedback and other issues relating to the efficient operation of the Centres.
- 3.1.9** Ensure all items on the Gym checklist are completed on shift.

#### **4. Core Physical Requirements**

- 4.1** Capacity to lift items unspecified in weight within individual limits.
- 4.2** Capacity to demonstrate or communicate without hindrance the exercises prescribed as per professional training, and ability to model progressions & regressions as appropriate.
- 4.3** Capacity to walk up and down stairs frequently.

#### **5. Accountability and Extent of Authority**

- 5.1** Gym instructors are accountable to the Aquatic & Health Programming Coordinator.
- 5.2** Work is performed within specific guidelines and under general supervision.
- 5.3** Gym instructors have the authority to enforce Mitchell Leisure Centre's conditions of use regarding the safety and orderly behaviour of patrons.
- 5.4** Maintain relevant records of tasks, activities and issues that have arisen during the shift.
- 5.5** Take appropriate actions in the event of a safety, first aid or security incident, ensuring that the Aquatic & Health Programming Coordinator or Duty Manager are briefed appropriately.

#### **6. Judgement and Decision Making**

- 6.1** The incumbent is responsible for making decisions relating to the day-to-day gym instructor duties at WSAC.
- 6.2** The objectives of the role are clearly defined with procedures clearly documented.
- 6.3** Guidance and advice will always be available; however, in the event of an



emergency the incumbent must have the ability to initiate the appropriate response, acting as an area warden depending on the situation.

## **7. Knowledge and Skills**

### **7.1 Specialist Skills and Knowledge**

- 7.1.1** Good physical fitness and a sound knowledge of fitness education.
- 7.1.2** Ability to solve minor customer problems and complaints in a fair and equitable manner.
- 7.1.3** Demonstrated commitment and capacity to work flexible hours to reflect the operational requirements of the service.
- 7.1.4** Ability to supervise and deliver fitness classes to a range of age groups and ability levels.
- 7.1.5** Knowledge of Occupational Health and Safety procedures and practices within a fitness setting and the Centre's emergency procedures.

### **7.2 Management Skills**

- 7.2.1** Ability to handle difficult situations, including emergencies, calmly and decisively.
- 7.2.2** Ability to remain focused during challenging periods including peak service delivery.
- 7.2.3** Gym instructors must have good organisational skills, program planning and timemanagement skills.
- 7.2.4** Ability to maintain accurate records.
- 7.2.5** Ability to assist and support other staff, where necessary, to ensure smooth operation of fitness and health programs.

### **7.3 Interpersonal Skills**

- 7.3.1** Ability to follow instructions and guidelines.
- 7.3.2** Approachable, positive attitude and the ability to relate to the patrons in a friendly, helpful manner.



- 7.3.3** Strong people skills, including the ability to convey instructions and information to patrons and gain the cooperation of patrons in the administration of safety requirements.
- 7.3.4** Good written communication skills for the purpose of completing routine work forms, including experience in Microsoft Office and centre management software (Perfect Gym).
- 7.3.5** Ability to interact effectively with customers from a range of backgrounds, age groups, abilities and fitness levels.
- 7.3.6** Display confidence and flexibility in service delivery and the execution of tasks.
- 7.3.7** Ability to use own initiative and demonstrate self-motivation.

## **8. Qualifications and Experience**

- 8.1** Experience in a busy leisure centre environment, assessing and delivering on clients' needs while also providing supervision of a gym space.
- 8.2** Experience in designing and modifying individual programs to suit client's health needs and goals.
- 8.3** Passion for continually learning and valuing professional development and new innovations in the field.
- 8.4** Strong ability to connect and build relationships with diverse clients.
