3. Key Responsibilities

- **3.1** Assist the senior public facilities cleaner to clean public amenities, in accordance with the Rural City of Wangaratta specifications and standards.
- 3.2 Operate appropriate motorised cleaning equipment in accordance with manufacturer's specification.
- **3.3** Maintain accurate work diary, timesheet, work and inspection records.

4. Core Physical Requirements

- **4.1** Capacity to perform heavy manual cleaning and maintenance repair duties.
- **4.2** Capacity to, on occasion, lift items unspecified in weight within individual limits from ground level.
- **4.3** Capacity to bend the knees, step up and down from plant & equipment frequently.
- **4.4** Capacity to kneel or squat for short periods.
- **4.5** Capacity to walk on uneven surfaces.
- **4.6** Capacity to work in an outdoor environment for varying periods of time.
- **4.7** Capacity to drive a motor vehicle.

5. Accountability and Extent of Authority

- **5.1** Accountable for assisting the senior public facilities cleaner to clean public amenities, in accordance with the Rural City of Wangaratta specifications and standards.
- 5.2 Accountable for fulfilling obligations under the Occupational Health and Safety Act and Council's Occupational Health and Safety Policy.
- **5.3** Authorised to take appropriate action to ensure the safety of staff, and members of the public.
- **5.4** Accountable for maintaining an accurate work diary, timesheet, work and inspection records.

6. Judgement and Decision Making

- **6.1** Tasks are undertaken using established procedures and are clearly defined within cleaning standards.
- **6.2** Problem solving will require some originality in approach with solutions usually attributable to applications of previously encountered procedures and practices.
- **6.3** Provision of guidance and advice will always be available.

7.1.1 Ability to assist the public facilities cleaner in the safe and efficient cleaning of public amenities.

7.3 Interpersonal Skills

- **7.3.1** Ability to understand and follow written and verbal instructions.
